- A. Mr Soh Loong Chow Jackie (“**Mr Soh**”), the Business Development Director of the Company has been re-designated as Executive Director and Chief Executive Officer (“**CEO**”) of the Company, effective 17 November 2025.
- B. Mr Tan Jit Meng (“**Mr Tan**”) has relinquished and ceased as Executive Director and Managing Director of the Company, effective 17 November 2025. Mr Tan has been re-designated as an Executive Officer of the Company and will continue to hold the position of Managing Director of the Group’s subsidiary, Lincotrade & Associates Pte Ltd.
- C. Mr Tan Chee Khoo (“**Mr CK Tan**”), the Operations Director of the Company, will be re-designated as Chief Operating Officer, effective 17 November 2025. There will be no change to Mr CK Tan’s roles and responsibilities in the Group.
- D. Consequent to the abovementioned changes, the composition of the Board will be as follows with effect from 17 November 2025, while the composition of the Board Committees remains unchanged:
